Pursuant to the provisions of Section 161(1), and Section 149 of the Companies Act, 2013 and the Articles of Association and is eligible for appointment. The Company has received recommendation from NRC under Section 160 of the Act proposing Mr. Raghu Perandurai Vasudeva Rao, as a candidate for the office of a Director.

As per the provisions of Section 149 of the Companies Act, 2013 ("Act"), an Independent Director shall hold office for a term up to five consecutive years on the Board of a Company and is not liable to retire by rotation. Mr. Raghu Perandurai Vasudeva Rao has given a declaration to the Board that he meets the criteria of independence as provided under Section 149 (6) of the Act.

The matter regarding appointment of Mr. Raghu Perandurai Vasudeva Rao as Independent Director was placed before the Nomination and Remuneration Committee, which recommended his appointment as an Independent Director.

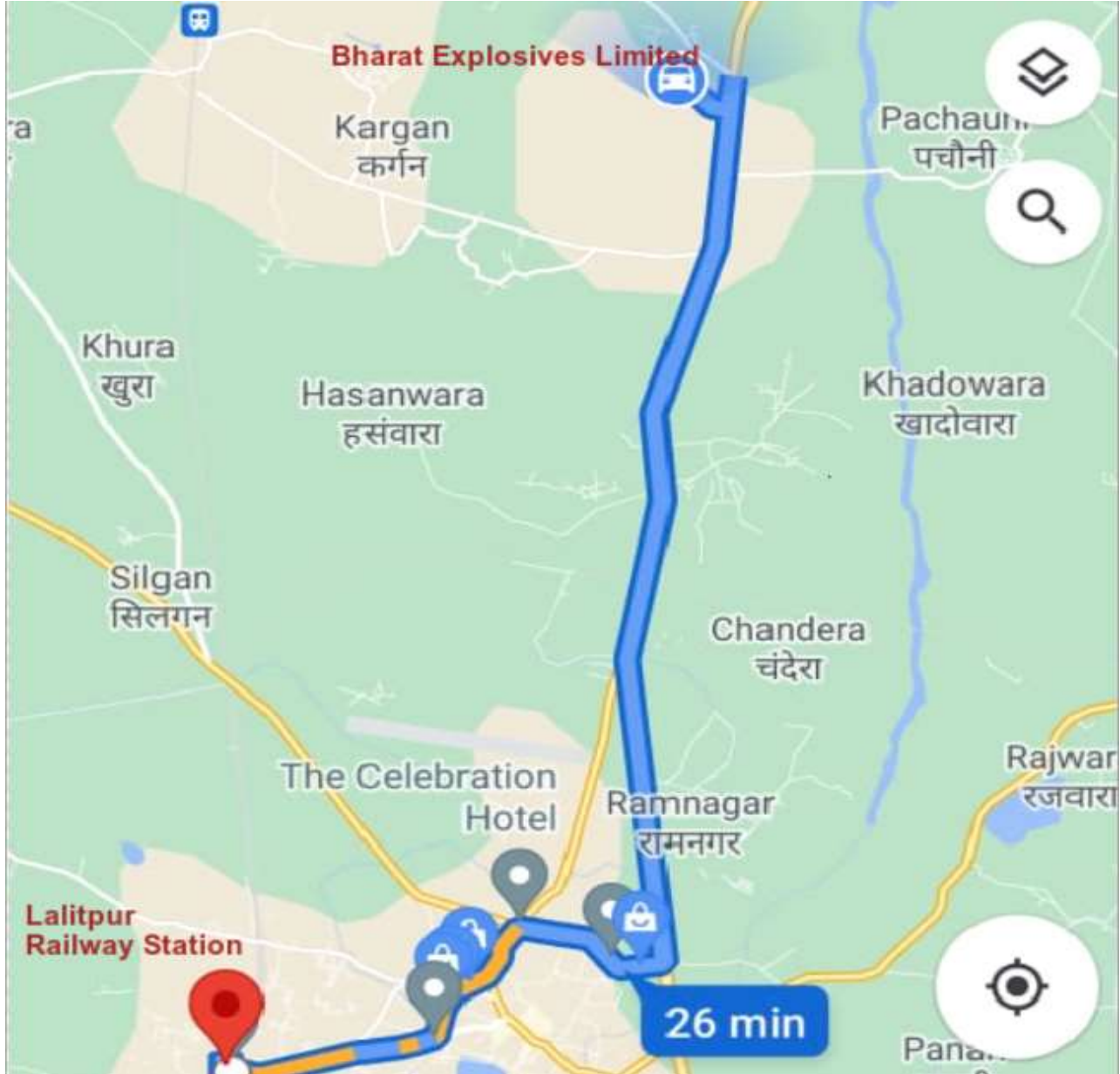
